60-DAY NOTICE TO TERMINATE TENANCY

NOTICE is hereby given that the tenancy under which you occupy the premises described above is terminated sixty (60) days from the date of service on this notice on you.

You are required to vacate the premises on or before the date of termination. If you do not surrender possession on or before that date, legal proceedings will be commenced against you to recover possession of said premises, and to declare the forfeiture of the rental agreement under which you occupy the premises. Rent for the premises is due and payable through and including the date of termination.

Pursuant to Civil Code Section 1950.5(f), you have the right to request an inspection of your rental and to be present during that inspection which shall occur no earlier than two weeks prior to the termination of the tenancy. Please contact the owner/agent if you wish to request an initial inspection.

Pursuant to Civil Code Section 1946.1(h), state law permits former tenants to reclaim abandoned personal property left at the former address of the tenant, subject to certain conditions. You may or may not be able to reclaim property without incurring additional costs, depending on the cost of storing the property and the length of time before it is reclaimed. In general, these costs will be lower the sooner you contact your former landlord after being notified that the property belonging to you was left behind after you moved out.

Pursuant to Civil Code Section 1946.2, Tenant is entitled to relocation assistance in an amount equal to one-month's rent. Owner elects to compensate tenant by waiving rent for the final month of tenancy, or, if checked, _____ by providing direct payment to tenant within 15 calendar days of providing this notice.
